From our HOA President

It is hard to believe that in just a few short weeks our pool will be open again for the season. Covid changed many things last

year and some of our annual traditions could not happen. We are excited to be able to offer our annual events again this year like Splash Day and the Garage Sale.

Your board continues to meet monthly. We have met with the City of Arlington on several occasions and will continue to reach out to the city on all matters that have impact to our neighborhood. Board meetings are open to any ELE resident. We meet the third Wednesday of each month at 7:00 pm in the Clubhouse – you are welcome to attend.

We are pleased to welcome two new board members. Scott Woods has agreed to serve as Boat/ Dock Chair. He has been boating since he was a boy and is very passionate about water and boat safety and the responsibility of being a boat owner. This is a great new addition to our board. We also welcome Elisabeth O'Brien as Communications Chair. Lizzie and her family have recently moved to ELE from California. She brings a wealth of knowledge and expertise to this position and we are fortunate to have her join the board.

Our main job as a volunteer board, comprised of homeowners, is to manage and monitor the budget, ensure that all common areas are maintained and offer community events. And while we are certainly happy to respond to complaints, it is not our job to police the neighborhood. We respond to complaints that come to our attention. Most times issues can be resolved by just talking to your neighbors and working out a feasible solution. Depending on the issue, the next step would be to contact the City of Arlington Code Compliance department at https://www.arlingtontx.gov/city_ hall/departments/code_compliance/get_involved. Here you can find all kinds of resources that are available to City of Arlington residents.

As we noted at our annual meeting in September of 2020, the Board will be proposing an HOA dues increase. This dues increase will be voted on at the annual meeting on September 19, 2021 with the increase beginning in 2022. While we are currently meeting our budget, with increased costs and unexpected expenses it is difficult for the HOA to maintain our annual budget AND build adequate levels of operating cash reserves. We also know that improvements and upgrades like security cameras and Wi-Fi at the clubhouse are needed and will increase our budget each year. Aging capital systems and maintenance of the common areas require that we maintain the right level of operating cash reserves. We do not want to put the Association in a position where we would have to seek a special dues assessment. Proper planning and budgeting are paramount. Because of this we will be proposing an annual HOA due increase from \$450 to \$600. This will be a two-year increase of \$75 each year. Your proposed dues for 2022 will be \$525 and for 2023 annual dues will be \$600.

Thank you again for allowing me to serve as your President. It is a pleasure to work along with so many great Board Members for the benefit of Enchanted Lake Estates.

Neighborhood Grant Update

The Arlington City Council has determined that "Champion Great Neighborhoods" is a priority for our city. Great neighborhoods contribute to a higher quality of life and investment in our economy.

The ELEHOA was offered an opportunity to apply for the Neighborhood Matching Grant Program. Unfortunately, our first attempt at securing funds through this grant initiative for dock improvements was not approved. As a result of the City review, the proposed project was determined to be ineligible for the following reason: The project is contained within a locked gated area and is not accessible to the general public, and not a public benefit. I assure you that we will continue to attempt to secure funds through this Grant opportunity and are currently working on defining eligible projects.

A recap of capital improvements and maintenance for fiscal year 2020 provided significant upgrades to our aging infrastructure. Some of the major initiatives included:

New LED light fixtures at all three entrances to our neighborhood

Dead tree removal around clubhouse

\$2,000

Replaced ruptured main water line from the street into our clubhouse

Planning a summer party? The ELE pool is a fantastic option! Private pool parties can be scheduled during the following time blocks:

Monday: 4pm-6:30pm, 7:30pm-10pm Tuesday-Friday: 9pm-Midnight Saturday: 9am-11am Sunday: 9am-Noon, 8:30pm-10pm



Security Deposit: \$200 refundable damage deposit (refunded within 48 hours after the party less any applicable charges). **Private Party Fees:** \$25 base fee plus \$10 per hour. **Lifeguard Fees:** \$25 per lifeguard per hour (one lifeguard required for every 20 guests; two lifeguards minimum per party.) For children's parties, one adult chaperone is required for every 20 guests.
