A little about Oncor, as many of you know, Oncor came through here a couple of months ago and began removing trees from the right of way and from the easements. This was a departure from their common practice of trimming the trees. We battled with them over this new policy and after many lengthy discussions and a few trips to speak before City Council, Oncor agreed to stop the tree removal. Unfortunately for us, by that time, they had already removed most of the trees they needed to in our area. In addition to developing a new policy of "selective trimming" in the future, Oncor made a few concessions to our neighborhood. Anyone who lost a tree or loses a tree, within the next twelve months, due to Oncor's actions, will be compensated \$1,200.00 per tree. They also agreed to come back through with some professional tree trimmers and touch up the rough cuts on all the trees that had been hacked at the beginning of the project. Finally, Oncor has agreed to erect a fence to cover the new cell phone tower equipment on the north side of Lake Mead between Falcon Lake and Lake Pontchartrain. The architecture committee will determine what kind of fence Oncor will put up.

Now that the canal work is finished, I would like to mention that it is up to all of us to make sure to keep it clean and free of debris. In the last few weeks, we have pulled some very large tree limbs that were stuck under the canal. These limbs were clogging up the canal and accumulating trash. These were not limbs that had broken off a tree and ended in the canal from runoffs. These limbs were cut with some kind of saw and probably dumped in our canal. I am sure that none of us would do that, but I would ask you to keep your eyes open for anyone outside the neighborhood that might be doing this. I would like to put a stop to this illegal dumping and any help is appreciated.
