Be sure to give a detailed description, as well as an address or exact location where the violation is taking place. They will respond by order of severity of the problem.

Another issue as summer time approaches and the weather improves are social gatherings in ELE. Remember to always be courteous to your neighbors in regards to visitor parking and noise. Visitors should not block driveways, play loud music, rev engines, spin tires, and most of all set off security systems.

Our main focus this year continues to be enforcement of the Covenants and Restrictions of ELE. Our goals are to increase property values and work to improve the community in every way possible. ## Clubhouse Renovation, an Update!

Our pool committee has completed its review of contractors and is ready to begin phase 1 of the clubhouse renovation project budgeted for this fiscal year. To ensure that this does not conflict with some of the upcoming events scheduled at the clubhouse, the renovations will not begin until after June 10.

"Phase 1" will include remodeling of the bathrooms and foyer to the clubhouse, maximizing the space and upgrading our bathrooms to meet code compliance. There will also be a new changing table for babies! Air-conditioning and duct work will also be part of this renovation; providing us with greater efficiency and reduced electricity bills. The construction will take a few weeks, but care will be given to minimize disruptions for our pool goers.

"Phase 2" will address the main room- and is tentatively scheduled for next winter pending budget approval.
